It is expressly understood that your purchase of our product acknowledges that Train Industries is not responsible or liable for determining the suitability or compatibility of our product for the user's intended purpose.

## **YOUR LEGAL RIGHTS:**

This constitutes your entire express warranty for the product purchased. To the extent permitted by law, all other warranties, whether express or implied, including, but not limited to the implied warranties of MERCHANTABILITY and FITNESS FOR A PARTICULAR PURPOSE are EXCLUDED. ### **FILING A CLAIM:**

Proof of purchase must be submitted with any notice of claim. We have the right, without any obligation, to physically inspect, perform testing, and obtain samples at the site where the warranty claim occurred, or to engage an independent third party for those services, before we determine the validity of your claim. In order to perform (or have performed) the services described in the prior sentence, the owner of the site consents to reasonable access for such services and agrees to pay for those services and all related costs of Train Industries if the claim is invalid under this warranty. Your claim must be received and evaluated by us before any repair or replacement work is performed; otherwise, this warranty will be null and void.

**YOUR EXCLUSIVE REMEDY:** If our product is proven defective within the applicable warranty period of one year, you will receive, as your sole remedy, replacement product and reimbursement of your reasonable and substantiated costs and labor for only that specific portion of the original installation requiring replacement.
